Contest 1: Fort Garry Industries SPIN TO WIN PROMOTION

Game Play: Between April 1 and 30, customers who purchase any product(s) from participating Spring Carnival sponsor vendors are eligible to earn a Spin to Win code. Spin Codes can be found printed on qualifying invoices and are limited to 1 per invoice. There is no limit to how many qualifying invoice Spin codes a customer can enter, however each qualified code can only be used once. The Spin-to-Win Wheel closes at 4:00 p.m. CST on April 30, 2021 and any unused Spin Codes will become invalid at that time.

Customers must enter their spin code in the FGI Spring Carnival Website at www.fgispringcarnival.com. Participants are required to enter a valid email address in order to play.

Qualifying Invoices: Minimum quantity of 1 product belonging to a Sponsor Vendor.

If a customer wins a prize, they will be required to provide some personal information so that FGI can get their prize to them. FGI does not share or sell personal customer information.

Spin-To-Win players who win will be notified by email if they have won a prize. Winners will be required to bring their prize notification and pick up the item(s) at their nearest FGI Branch location. If alternate shipping arrangements are required for any prize(s), the winner must advise their FGI branch representative. Any such alternate prize shipping arrangements would be at the winners expense if required.

Qualifying Purchase: Minimum quantity of 1

Exclusions: Entries associated with invoice returns.

ADDITIONAL TERMS:

1. Contest Period: April 1, 2021 through April 30, 2021
2. NO PURCHASE IS NECESSARY TO ENTER OR WIN.
3. The Spring Carnival contests are offered in 14 FGI Aftermarket Parts locations, and online at www.fgispringcarnival.com. (collectively "Participating Stores"). This contest is only open to customers who are legal residents of Canada and have reached the age of majority in the province or territory in which they reside, ("Eligible Participants"). Employees of FGI, its affiliate locations, vendors, and members of their immediate families living in the same household are not eligible to enter.
4. There are two ways to obtain entry into the contest:

AUTOMATIC ENTRY: Eligible Participants will receive one (1) automatic entry into the contest when they make a purchase of qualifying products from participating vendors at participating FGI locations during the Contest Period. One (1) automatic entry will be generated for each qualifying invoice. Purchases made "to follow" after the Contest Period, and purchases made within the Contest Period that are returned before the end of the Contest Period are not eligible to receive an entry.

For the purpose of each contest, the purchase date is defined as the date on which an invoice is either generated or posted to the customer's account.

NO PURCHASE ENTRY: To enter without making a purchase, during the Contest Period hand-print on a piece of 8 ½" X 11" paper the date, your full name, address, city, province or territory, postal code, day and evening telephone numbers, your account number (if any), and an original, legible 50-word handwritten essay titled <CONTEST NAME> and answers the question "Why do you like to shop at FGI?" and mail it in a postage-stamped envelope to: Fort Garry Industries "Spring Carnival Contests" Attention: FGI Marketing Team, 2525 Inkster Blvd., Winnipeg MB, R2R 2Y4.

Eligible Participants will receive one (1) entry into the Contest for each eligible no-purchase entry request that is postmarked by the last day of the Contest Period and received by FGI by 3:00 p.m. ET on Wednesday, May 5th, 2021. Maximum of one (1) no-purchase entry request allowed per envelope, per day, with sufficient postage. Essay must be original, not duplicated. Each request must be mailed separately, bear sufficient postage and must be received by required date. FGI will not be responsible for lost, late, stolen, damaged, delayed, misdirected or postage-due entries. No mechanical reproductions permitted. Duplicate entries discovered will disqualify all entries submitted by that person. Incomplete or illegible entries will be disqualified.

All entries become the property of FGI and will not be returned. All entries are subject to verification. FGI reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility to participate in this Contest. Failure to provide such proof in a timely manner may result in disqualification.

The Prize(s) will be awarded to the individuals or purchasing authority of the company name posted to the invoice associated with the selected entry or individual who entered without making a purchase.

5. Starting the week of Wednesday, May 5th, 2021, at FGI Head Office, 2525 Inkster Blvd in Winnipeg, random selections of one (1) entry from among all eligible automatic and mail-in entries received for each contest will take place.

FGI will attempt to contact each selected entrant or authorized company representative up to three (3) times by telephone/email (at the telephone number/email address provided at the time of entry for mail-in entries, or on file with Sponsor for automatic entries). Each selected entrant will be required to: (i) correctly answer a time-limited, arithmetical skill-testing question to be administered at a mutually convenient time and without assistance, (ii) confirm his/her eligibility and (iii) complete, sign and return within seven (7) business days of notification the Sponsor's Contest Declaration & Release form before he/she can be declared a winner. If a selected entrant cannot be contacted within seven (7) days following the draw, fails to correctly answer the time-limited arithmetical skill testing question, fails to sign and return the Declaration & Release form within the required time period, or otherwise fails to comply with these Rules and Regulations, that selected entrant will be disqualified, will forfeit his/her prize and will have no further recourse.

FGI is not responsible and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify a selected entrant. FGI will not be responsible for any loss, theft or misuse of the prize. Availability of the prize may be up to six to eight weeks after the Declaration and Release form has been received.

Each Prize must be accepted as awarded. No substitution or transfer of a Prize is allowed except at the sole discretion of Fort Garry Industries Ltd who reserves the right to substitute a Prize of comparable value. Prizes have no cash or credit value, cannot be applied to previous purchases or used for account payments.

8. By entering the contest, or by making a Qualifying Purchase during the Contest Period, entrants agree to being automatically entered into the Contest, and to abide by these contest Rules and Regulations and the decisions of FGI, which are final.

Each winner may be required to sign and return within seven (7) days of receipt a standard declaration and release form confirming compliance with these rules and waiving any liability of FGI, and their respective agencies, affiliates, employees, officers, directors, merchant agents and FGI store operators arising out of the conduct of the contest and the acceptance and use of the prize as awarded.

FGI is not responsible for telephone, technical, network, online, electronic, computer hardware or software failures of any kind, or for entries that are stolen, misdirected, incomplete, garbled or delayed by computer transmissions due to technical problems or internet traffic congestion or at any Web site, or any combination thereof, including any injury or damage to participants' or any other person's computer resulting from downloading of any materials or participation in this contest. FGI shall, in its absolute discretion, disqualify any individual found to be tampering with the operation of the Web site or the administration of the contest. If, for any reason, the contest is not capable of running as planned, or if the administration, security, fairness, integrity, or proper conduct of the contest is corrupted or adversely affected, including by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any causes beyond its control, FGI reserves the right to cancel, terminate, modify or suspend the contest, including cancellation of the method of entry and selection of a winner from previously received entries.
